Certificate Programs

OSHA's Safety and Health Fundamentals Certificate Program supports OSHA's mission by training employees in occupational safety and health to reduce incident rates for workers. The certificate program is separated into tracks for Construction, General Industry and Maritime Industry. For the Construction and General Industry tracks, participants must successfully complete a minimum of seven courses, comprised of three (3) required courses (minimum 39 hours), and at least four (4) electives (29 hours). ncstateies.com/OSHACertificateProgram

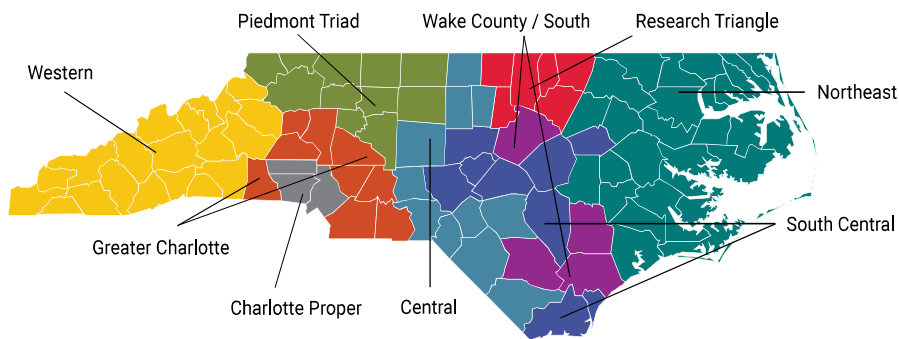
